

## **Terms of Use ("Terms")**

Please read these Terms of Use ("Terms", "Terms of Use") carefully before using the <http://geocities.ws/greatlittlemadison> website (the "Service", the "Site") operated by the Kyle Jenks who portrays President James Madison and other historic and fictional individuals ("Mr. Jenks", "us", "we", or "our").
